- **STEP 01.** The authors of the studies contact the PSHA Office for information about the solicitation of the membership for participation in their research.
- STEP 02. The PSHA Office contacts the author(s) to confirm the IRB approval for the research and to solicit the information for dissemination. The author(s) should forward a copy of the documentation related to the IRB approval to the PSHA Office (to be filed) and should forward a summary of the appeal for participation created in the format above.

STEP 03. The PSHA Office also provides information to the authors about the PSHA Journal (such as the most recent call for submissions) and extends an invitation to the authors to consider submission to this Journal as part of their plans for their publication of their work.

**STEP 04.** Upon receipt of the documentation related to the IRB approval and the information for dissemination, the PSHA Office will distribute the appeal for participation in the approved format (see below).
