Course Abstract

This presentation provides an overview of the Pennsylvania State Board of Examiners in Speech-Language and Audiology, including its members, purpose, duties, and vision. It outlines licensure requirements, continuing education processes, telepractice guidelines, and recent legislative updates. Additional sections will address multi-state compacts, practical scenarios for licensure portability, and distinctions between licensure and certification.

This presentation outlines the role of the Pennsylvania Office of General Counsel (OGC) in supporting the State Board of Examiners in Speech Language Pathology and Audiology. It highlights the importance of professional licensing in protecting public welfare and explains how the Bureau of Enforcement and Investigation (BEI) receives and investigates complaints. Key investigative responsibilities, annual case statistics, and typical disciplinary outcomes—ranging from warnings to formal charges—are summarized. The presentation also explains the steps in the disciplinary and appellate processes and concludes with board contact information for legal and procedural guidance. The presentation will conclude with opportunities for public involvement, meeting details, contact information, and a question-and-answer session to review content.
