Literature suggests stakeholder coaching leads to better outcomes in AAC acquisition, implementation, and use; however, there remains a need for greater supports in AAC service-delivery. Individuals, families, and teams face a shortage of experienced AAC providers and other systemic limitations. This session will provide insight into TechOWL's (Pennsylvania's AT Act program) AAC initiatives and how SLPs in other states can adapt and use this model in their communities. Presenters will discuss strategies for development and application of a virtual, consultative coaching model for AAC that participants may adapt and use within their own practice and caseload.
